BRIDAL CONTRACT

Thank you for choosing me for your big day! Please carefully review this contract and return it to me via email or in person. The complete balance for your bridal party will be due on or before your wedding date, _____. Please feel free to contact me at any time with questions or concerns. I am looking forward to being a part of your special day!

Policies

BOOKINGS- To secure a wedding date, a signed bridal contract is required, as well as a non-refundable deposit of \$50 to secure the date. I accept Cash, Venmo, PayPal or card for the deposit. (PLEASE NOTE THERE IS A 3% SURCHARGE FOR ALL NON-CASH TRANSACTIONS)*YOUR DATE IS NOT SECURE UNTIL I HAVE RECEIVED THE DEPOSIT*

NUMBER OF SERVICES - I require a MINIMUM of 4 services to book my Saturdays! If I arrive Saturday morning and the number of services is under 4 - The bride is responsible for paying the difference.

CONSULTATION/TRIALS- All trials must be specified in the contract below. All trials will take place at Balancing Touch Spa, in Plover.

Travel Fee- A mileage fee of (\$1.00 / mile both ways) will be charged for locations outside of Plover, WI. This travel fee is separate from makeup fees. I do not split travel fees if there is another makeup artist needed.

Balancing Touch Spa (1840 Post Rd, Unit #4, Plover, WI) - If you would like to book without a travel fee you are more than welcome to come to Balancing Touch Spa, Plover, WI.

Liability- All Brushes, Tools & makeup products are sanitized between every service. Any allergies or skin conditions should be reported to the makeup artist prior to service. Client(s) agrees to release the makeup artists from liability for any skin complications due to allergic reactions!

Payment- The final balance is due on or before the day of the event, before the makeup artist departs- NO EXCEPTIONS. The person(s) responsible for the entire payment is the person(s) whose name(s) appears on this contract. On the day of the event payment is preferred as cash.

Photo Release Agreement- By signing this contract you are also authorizing the makeup artist to use photos for their websites or other social media platforms for services that are performed.

Prep Instructions- Please come to your appointment with a clean face. * I do offer bridal facial packages for the bride and bridal party prior to the special event. This ensures an amazing canvas for makeup application on the special day! *

Contradictions- By signing this contract you understand I cannot perform makeup services in unsanitary conditions. A refund will not be issued if I cannot work due to unsanitary conditions. Also, I cannot perform makeup if somebody has conjunctivitis (pink eye), Stye or Cold Sores Present.

Wedding Day- I will show up 15-30 minutes before the start time to set up. I require there to be outlets.

Lash Application only -----\$15
- Makeup Trial -----\$85

PRICING On-site (specified location)

- Brides Makeup Application -----\$105 (includes lashes & makeup touch up kit)
- Makeup Application ----- \$95 (includes lashes) •
- Lash Application only -----\$15

Day of - If I must wait 10 minutes in between services due to the person(s) attendance, an additional \$5 will be charged per 5 Minutes of additional wait time.

HOW TO PAY: Cash payment is preferred, but I do accept Venmo, PayPal, and card (only if I'm on site at the spa). There is a 3% fee added to ANY NON-CASH transaction.
